The Plain Township Board of Trustees met in regular session at the Plain Township Fire Station, 9500 Johnstown Road, New Albany, Ohio.

Mr. Olmstead called the meeting to order with the Pledge of Allegiance to the flag.

Roll Call: Members Present Mr. Olmstead and Mr. Rybski. Mr. Ferguson was absent. Mr. Zappitelli, Fiscal Officer, was present. Other people present were Chief Hoovler, Assistant Chief Rupp, Ben Collins, Bob Pharris, Cindy Powell, Battalion Chief Ecleberry, Captain Dudley, Lieutenant Pabst, Firefighter Noble and Firefighter Dozier.

Visitors present were Dr. Glyde Marsh and Boy Scout Troop 450.

ADDITIONS OR CORRECTIONS TO THE AGENDA

Mr. Zappitelli requested an executive session.

APPROVAL OF MINUTES

Mr. Rybski made a motion to approve the March 21, 2018 Board of Trustees Meeting minutes as submitted. Mr. Olmstead seconded the motion.

Vote: All Aye (Resolution 18040401)

PAYMENT OF THE BILLS

Mr. Rybski made a motion to pay the bills in the amount of \$301,292.87. Mr. Olmstead seconded the motion. Vote: All Aye (Resolution 18040402)

LADDER TRUCK COMMITTEE PRESENTATION

Battalion Chief Ecleberry presented the Ladder Committee report. He gave a brief overview of how the first Sutphen ladder truck was purchased. He said it has been a great truck and due to the preventative maintenance it has lasted 21 years. He said that the maintenance costs have been increasing so they tried to identify a timeframe to replace the truck.

Battalion Chief Ecleberry said in 2017 Chief Hoovler asked him to put together a committee to start collecting data and information to put together a report with a plan to replace the ladder. He said they wanted officers and firefighters so they had a wide spectrum of experience on the committee. The Ladder Truck Committee members are Bn. Chief Ecleberry, Capt. Dudley, Lt. Pabst, FF Noble, FF Dubeck and FF Powell.

Bn. Chief Ecleberry said that Capt. Dudley has been our maintenance person for over 20 years. So he and FF Noble have a lot of experience mechanically. He said Lt. Pabst, FF Noble and FF Powell have a lot of experience riding on the truck.

Bn. Chief Ecleberry said they set out the goals for why we need to replace the truck so they looked at maintenance costs and the current condition of the truck. He reviewed the criteria for truck replacement. He said the average lifespan for a 100' ladder truck in other townships is 13-15 years. So we are well beyond that at 21 years.

Mr. Olmstead said they did an excellent job on the report. He said they explained the condition and the need. Mr. Rybski concurred. Mr. Rybski asked about the height of the ladder truck. There was discussion on the differences in the ladder trucks including height, ladder sections, turning radius, storage and the firefighter training necessary on the new equipment.

Mr. Olmstead asked Bn. Chief Ecleberry to get together with the fiscal staff to review the financing options. He wants to make sure that we have funding available for a new ladder truck from an operating standpoint.

Bn. Chief Ecleberry thanked the Ladder Truck Committee on all of their hard work. Mr. Olmstead and Mr. Rybski thanked the committee.

ADMINISTRATOR

Mr. Collins said that he attended the Engineer's Office yearly meeting and reviewed the Bevelhymer Road issue with them.

He said that most employees completed their Wellness HRA Plan requirements. He said there are a few people who haven't yet finished those credits. Mr. Olmstead said that we need to roll the program over so the credits will go towards their 2019 requirements. Mr. Collins said anything above the 2018 requirements will automatically go towards their 2019 requirements. He said the question would be on whether we stick with the current cut off or provide a grace period for the remaining people to meet their requirements. Mr. Rybski asked what percentage of people haven't completed their requirements. Mr. Collins said we are about 97% complete. Mr. Olmstead said that he is willing to give people another week or two to finish their requirements. Mr. Rybski said that he has no objections if it doesn't disrupt the process. Mr. Olmstead asked Mr. Collins to extend the deadline two weeks or whatever date he feels is appropriate. He said please send people a reminder that they need to have it in by that date.

ZONING

Mr. Collins said that they received around two dozen responses to the Zoning Board vacancy notice. There was a brief discussion concerning the vacancies. Mr. Olmstead asked if there were any zoning applications pending. Mr. Collins said there is one application going to the Zoning Commissions so he would like to have someone appointed for the May Meeting so they can take action. Mr. Rybski said let's plan on making a selection at the next meeting. Mr. Olmstead agreed. Mr. Collins said that he thinks that they will have more qualified candidates than they have vacancies.

MAINTENANCE

Mr. Collins said they did hammer out terms with Whitewater for the slide refinishing. He said we are still looking at April 15th for them to be on site.

Mr. Rybski gave an update on the Bevelhymer Road ditch. He said that he had a meeting last week with the Franklin County Engineer's Office. They brought a team together to review options for trying to remedy the issue. The discussion was generally that they needed to repair the road so it doesn't further deteriorate. He said there is a product that they recommended and said it would work. They will saw cut a foot or so of the pavement, build up the berm into the pavement to provide structure to hold a vehicle and then slope it down to the ditch which will be an open channel. He said to try and enclose the ditch is not feasible economically, having space or providing the capacity to have the water flow through there. It was a productive meeting and the conclusions were that the County Engineer's Office would put a cost to it. We had received a quote for a full ditch lining and the materials were \$14,000 but that was prior to them determining that they needed to saw cut the pavement and remove and replace a little bit of aggregate to build it up. They were hoping that they could provide, with their maintenance staff, the installation. There was a brief discussion concerning the cost and who will pay for it.

Mr. Pharris said he met with Harlem Township on Monday. He said there is a tile that goes under Bevelhymer Road on the north end almost to 60 is rotted out at the bottom. He has already purchased the tile and saw cut the road. I told him that we would try to share the cost and labor with them. There was a brief discussion concerning the road maintenance on that end of Bevelhymer Road and the scope of work that needs completed on the tile replacement. There was discussion concerning seasonal labor.

Mr. Olmstead made a motion to pass Resolution No. 180404M1. Be it resolved, to pay TruGreen Commercial Services of 461 Enterprise Drive, Lewis center, Ohio 43035 up to \$7,200.00 for lawn treatment and fertilization for 2018 to include services according to the attached proposal for the following facilities:

Mr. Pharris said that he got a quote to replace the carpet using carpet squares at the office just like the carpet squares at the Fire Station. The quote was \$8,680 which includes the fiscal office to replace the laminate flooring. The quote is for the back hallway, the fiscal offices, Ben's office and the rest of the Township side. He said this is the only quote that I have and they did a good job at the Fire Station. There was a brief discussion concerning the quote and type of carpet. Mr. Pharris said that he would get a couple more quotes.

FIRE DEPARTMENT

Chief Hoovler said there have been 76 runs since the last Board of Trustees meeting.

Mr. Olmstead made a motion to pass Resolution No. 180404F1. Be it resolved to approve out of state travel for Assistant Chief Rupp and members to be named to attend FDIC. The amount not to exceed \$300.00 for conference registration. The conference is held in Indianapolis, Indiana on April 23-28, 2018. Station vehicles will be used for transportation. Out of fund 10-A-15D. Fire District-Other Expenses-Training.

Mr. Rybski seconded the motion. Vote: All Aye

Mr. Olmstead made a motion to pass Resolution No. 180404F2. Be it resolved pay Physio Control \$10,647.00 for routine maintenance of all Physio Control equipment out of fund 10-A-10A. (Fire District – Repairs - Maintenance Agreements)

Chief Hoovler said that he wanted to bring to the Trustees attention that the firefighters are having issues with the health insurance and the HRA. There was a brief discussion concerning the health insurance related issues and direct employee expenses.

Mr. Collins said we received one final invoice from OPEC for 2017 reimbursements.

CITY OF NEW ALBANY LIASION

Dr. Glyde Marsh said there has been discussion concerning the parking issue. They are looking at ways to remedy the situation.

FISCAL OFFICE

Mr. Olmstead said that he would like to thank Mrs. Powell for assisting him with an ADP issue were he was unable to login.

Mrs. Powell said at the last meeting there was discussion and the Trustees agreed that we could make online ACH payments for Health Insurance related items. I found out that we can only do that for United Healthcare. The other vendors don't have that capability. I investigated online bill pay for those vendors and I wanted to make sure you approved of online bill payment for those payments. Mr. Rybski asked if there was a fee. Mrs. Powell said no, it was included. Mr. Olmstead and Mr. Rybski agreed that we could make the health insurance related payments with online bill pay.

NEW BUSINESS

There was discussion concerning a request for to assist with place making plaques to tell the story of the city.

Mr. Olmstead said there is a MECC Regional COG meeting on April 26th. On the agenda will be the continued transition of the dispatch services.

OLD BUSINESS

Mr. Olmstead said that he has not heard anything additional from the McCoy Stakeholders concerning the carpeting. They are waiting for carpet samples.

CITIZEN COMMENTS

Mr. Rybski said that he would like to recognize Boy Scout Troop 450 from New Albany. He said hopefully you found it interesting, educational and possibly serving as a public servant someday.

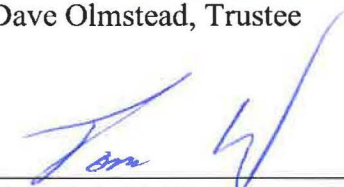

TruGreen may terminate this Agreement for convenience upon thirty (30) days prior written notice to you. You may cancel this Agreement for material breach by TruGreen provided that you give TruGreen written notice of the details of the breach, and thereafter TruGreen fails to cure the breach within thirty (30) days after said notice. (a) **Additional termination provisions for landscape companies, property management companies, agents and other similar entities:** To the extent you represent one or more property owners and/or properties covered under this agreement, and in the event such owner terminates your contract with regard to one or more properties, then upon notice to TruGreen, you may terminate this Agreement only as it relates to such property for which owner terminated its contract with you. To the extent that this Agreement applies to other properties, not terminated by the owner, this Agreement shall continue in full force and effect with regard to such other properties.

6 **Sale of Property** You agree to notify TruGreen in writing immediately in the event that you sell any property which is the subject of this Agreement. TruGreen shall make the appropriate adjustment in price to accommodate the reduction of square footage treated in the event that property is sold. In the event all property which is the subject of the Agreement is sold, this Agreement shall be terminated upon receipt by TruGreen of your written notice that you have sold the property. Should you fail to notify TruGreen as required in this provision, you agree to indemnify TruGreen for any damages incurred as a result of your failure to notify.

7 **LIABILITY** TRUGREEN IS RESPONSIBLE FOR DIRECT DAMAGES RESULTING FROM ITS NEGLIGENCE OR BREACH OF THIS AGREEMENT, BUT IS NOT RESPONSIBLE FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, PUNITIVE, OR SPECIAL DAMAGES ARISING OR RESULTING FROM THE PERFORMANCE OR NONPERFORMANCE OF ANY OBLIGATIONS UNDER THE AGREEMENT INCLUDING, BUT NOT LIMITED TO, LOSS OF PROFITS OR INCOME, REGARDLESS OF THE BASIS FOR THE CLAIM.

8 **Duty to inspect** You have a duty to inspect the property within fifteen (15) days after service has been performed by TruGreen. If you believe TruGreen provided deficient work, you agree to notify TruGreen immediately in writing. If written notice is not received by TruGreen within fifteen (15) days after the date of service, you agree that any and all claims alleging damage of any nature or to recover past payments and/or rights to withhold future payments due under this Agreement are waived.

9 **Notice to tenants, employees, invitees** To the extent necessary, you have a duty to notify all tenants, employees, visitors and any other invitee on the premises of a scheduled service prior to the performance of any scheduled service by TruGreen.

10 **No Warranties** Except as expressly set forth in this Agreement, TruGreen makes no warranty or representation of any kind, expressed or implied, concerning e, their products used or services performed, including no implied warranty of merchantability or fitness of the product for any particular purpose, and no such warranty shall be implied by law, usage of trade, course of performance, course of dealing, or on any other basis.

11 **Force majeure** Except for the payment of TruGreen's invoices owed by you, neither TruGreen or you shall be prevented or delayed in the performance of any or all of the provisions of this Agreement, by reason of any labor dispute, industry disturbance, delay in transportation, governmental, regulatory or legal action, act of God or any cause beyond such party's control, the obligations hereunder of such party shall be extended for as long as such cause shall be in effect and any delay or loss suffered by the other party shall not be chargeable in any way to such party, provided, however, the other party suffering such cause shall immediately notify the other party of such inability and shall use reasonable efforts to remedy same with all reasonable dispatch. Specific products, rates of application and method of application will vary with the season, weather conditions, and the needs of your lawn as determined by your TruGreen specialist. Your regularly scheduled programs may be modified depending on the weather and the condition of your landscape. The application methods and procedures used to perform service under this Agreement will be determined solely by TruGreen. Your TruGreen specialist will keep you informed on any modifications to this schedule.

15 **Insects and Borers** Total insect elimination is not desirable with any program because beneficial insects will be lost along with the targeted pests. Plants invaded by borers have a high probability of death or decline. Sound cultural practices and control applications may extend the life of some plant species. Treatment for boring insects may include additional cost. Consult your TruGreen specialist with details.

16 **Authorization to provide Service** TruGreen agrees to furnish labor and materials for purposes of this Agreement and is authorized by you to treat the property at the address shown above. You represent and warrant to TruGreen that you are the owner of said property, or in the event that you are not the owner of the property to which this Agreement applies, you represent and warrant that you have the legal authority to execute and bind the owner of the property to the terms and conditions of this Agreement.

17 **MANDATORY ARBITRATION** Any claim, dispute or controversy, regarding any contract, tort, statute, or otherwise ("Claim") arising out of or relating to this agreement or the relationships among the parties hereto shall be resolved by one arbitrator through binding arbitration administered by the American Arbitration Association (AAA), under the AAA Commercial or Consumer, as applicable. Rules in effect at the time the Claim is filed ("AAA Rules"). Copies of the AAA Rules and forms can be located at www.adr.org, or by calling 1-800-775-7879. The arbitrator's decision shall be final, binding, and non-appealable. Judgment upon the award may be entered and enforced in any court having jurisdiction. This clause is made pursuant to a transaction involving interstate commerce and shall be governed by the Federal Arbitration Act. Neither party shall sue the other party other than as provided herein or for enforcement of this clause or of the arbitrator's award; any such suit may be brought only in Federal District Court for the District or, if any such court lacks jurisdiction, in any state court that has jurisdiction. The arbitrator, and not any federal, state, or local court, shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, unconscionability, arbitrability, enforceability or formation of this Agreement including any claim that all or any part of the Agreement is void or voidable. To the extent that any terms set forth in an invoice should conflict with the terms set forth in this Agreement, this Agreement shall control. No terms, conditions, or warranties other than those stated herein or in any invoice issued by TruGreen, and no agreements or understanding, oral or written, in any way purporting to modify these conditions shall be binding on the parties hereto unless hereafter made in writing and signed by authorized representatives of both parties.

Executive Summary

The Plain Township Fire Department currently operates a 1997 Sutphen Platform Ladder truck. At 21 years old, the maintenance costs to keep the truck running continue to rise and projected future repair costs are also rising. The number of days each year the truck in out of service for repairs has increased each of the last 5 years.

At the same time, the number of fire runs the truck responds on is increasing annually as the community continues to grow. A committee has been working the past several months preparing data that will demonstrate the need to replace the ladder truck.

Based on the findings of the committee, the committee recommends the following:

- **Acquire a new Sutphen SPH 100 Tower Ladder through state of Ohio bidding from Sutphen corporation.**
- **Place the order to purchase the truck in July 2018.**
- **Take delivery of the new Sutphen SPH 100 in the fall of 2019.**



The Ladder Committee

In early 2017, it became apparent that the condition of the Plain Township Fire Department ladder truck would not meet the former plans to replace the truck in 2022.

The Fire Chief assigned Battalion Chief Ecleberry to form a committee to begin collecting data on the current status of the ladder truck including information and projections on repair costs.

The ladder truck committee is comprised of experienced officers and firefighters from all 3 shifts on the department.

- **Battalion Chief Greg Ecleberry 3 Unit**
- **Captain Travis Dudley 1 Unit**
- **Lieutenant Chris Pabst 1 Unit**
- **Firefighter PJ DuBeck 2 Unit**
- **Firefighter Adam Noble 2 Unit**
- **Firefighter Mark Powel 3 Unit**

The primary goal of the committee in 2017 was collecting the following data:

- **Maintenance records and history of current ladder truck.**
- **Professional review of current ladder truck from Sutphen.**
- **Miles and Hours of current truck.**
- **Projections of maintenance and repair costs.**
- **Comparable data from area fire department ladder trucks.**
- **Review of commercial and multi-story residential development.**
- **Statistical data.**
- **Review of current technology in 2018 ladder trucks.**

Ladder Truck History

In 1995 Plain Township Fire Department was preparing for the future as the explosion of residential growth and numerous planned commercial developments began in New Albany. The Insurance Service Office (ISO) requires an aerial device in their rating schedule for any FD providing service to five or more buildings 3 stories or greater or five or more buildings requiring a fire flow of 3500 gallons per minute.

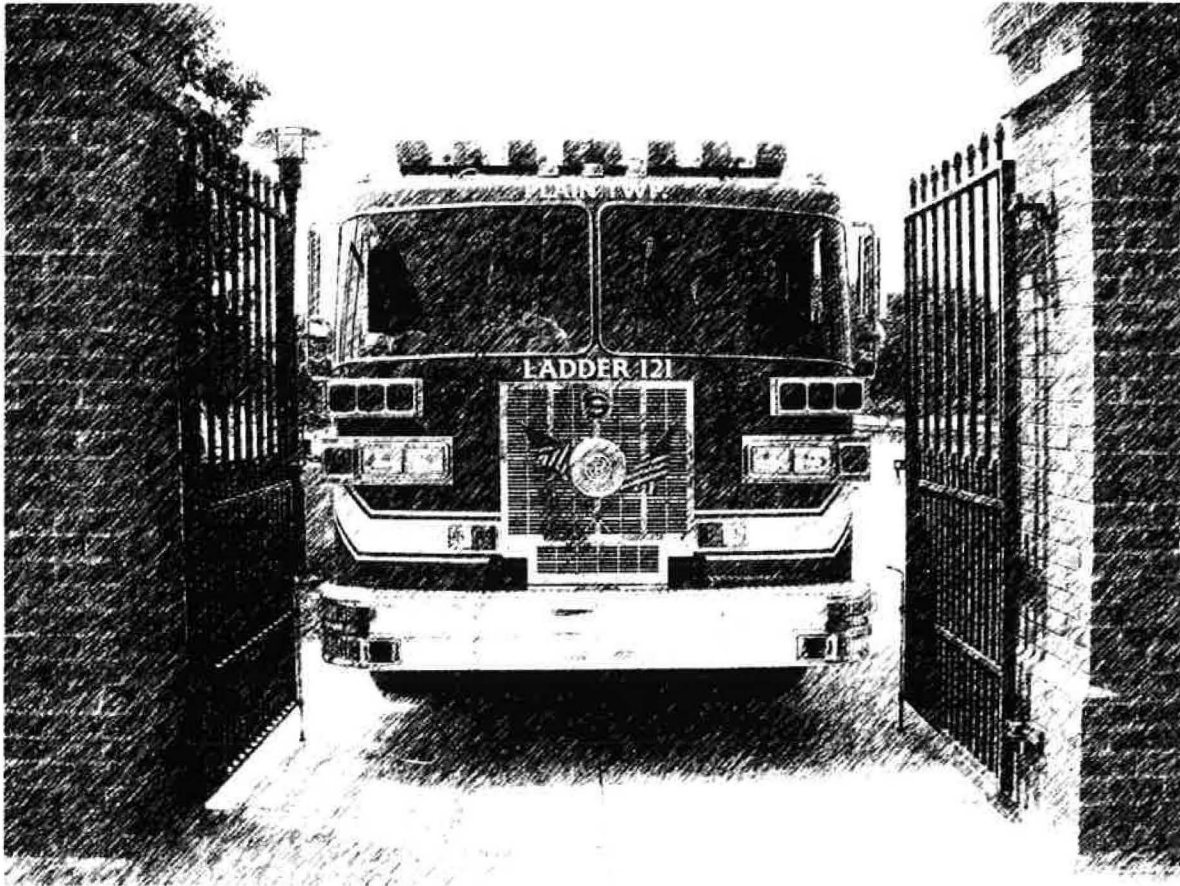
The New Albany Community Authority donated funding for the PTFD to purchase its first ladder truck. The department purchased a 100' ladder truck from Sutphen Corporation for \$600,000.

The ladder truck was delivered in the fall of 1997 and placed in service after training the staff on driving and operations of the truck.

Over the past twenty years the ladder truck has experienced a steady increase of runs annually. The truck responds on fire alarms, gas leaks, service calls, water leaks, smoke in the building, lightning strikes, chimney fires and structure fires. In 2017 the ladder truck responded to 498 calls.

Currently the ladder truck has 89,000 miles and 7800 hours of use.





Current Condition

The current condition of the ladder truck is separated into three different categories:

Maintenance Costs – This will show a steady increase in the amount of money being spent to keep the truck in service.

Future Maintenance – This will show what is currently in need of repairs and the anticipated repairs over the next 2-4 years.

Reconditioning Cost – This is an estimate to perform a major reconditioning of the current truck.

Current Condition Maintenance Costs

Over the past 10 years the cost of maintenance of the ladder truck has continued to rise.

Since 2009 the maintenance cost for repairs on ladder 121 has been \$61,522.35

This amount *does not* include preventive maintenance such as new tires, oil changes or regular annual maintenance.

Over the past 10 years the average annual maintenance expenses have increased from \$500 per year from 1997 – 2008, to \$6150 per year between 2009 and 2017. This is a direct result of an aging truck that is experiencing annual increases in activity and use.

The pump experiences leaks from multiple valves which requires frequent repairs. The truck experiences electrical issues, heating and cooling issues and has multiple body work and cosmetic problems.



Current Condition Future Maintenance

The current needed repairs for the ladder truck for 2018-2019 including repairing cracks in the cab, replacing the swivel and mounting flange are estimated to be \$35,000. This amount does not include unexpected mechanical problems or repairs.

Current Condition Reconditioning Cost

On April 24, 2017 the manufacturer (Sutphen) of the current ladder truck performed a complete review of the truck's mechanical components, motor, aerial ladder, pump and body.

At that time a complete recondition of the current truck was projected to cost \$431,924. It is estimated that the current cost today would be \$460,000. The estimated value of the truck is \$100,000.00.

This recondition does not upgrade any of the major components of the truck including the aerial, platform/bucket, safety components, pump, etc.

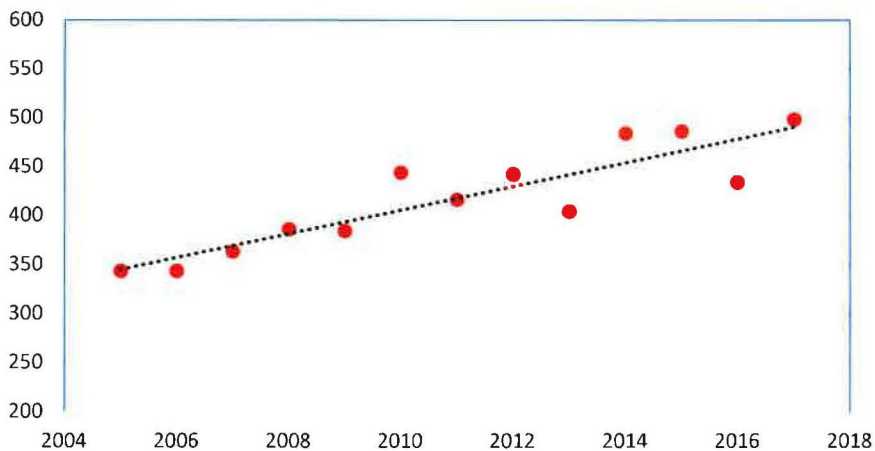

REPLACEMENT CONSIDERATIONS

The ladder committee identified several factors when determining the need to replace the current 1997 ladder truck.

- **Condition of current Ladder Truck**
- **Improved Technology**
- **Community Needs**
- **Financial Considerations**
- **Proposed Time Line**

The committee determined the current condition of the ladder truck's mechanical systems and body including motor, frame, cab, body, ladder systems, interior, electrical system and pump that the truck should be replaced as soon as possible.

The truck continues to experience an increase in mechanical break downs taking the truck out of service for several days. We expect this trend to continue as demonstrated in the rising maintenance expenses.

Over the past twenty years numerous technological advances have been made to all of the operating systems on new ladder trucks. This includes improved emissions, improved fuel efficiency, improved safety features in the cab and ladder systems.



Community Needs

The City of New Albany continues to grow and develop and that trend is expected to continue over the next 10 years. In particular, the commercial development in and around the town center, as well as the Smith's Mill Rd corridor and business campus has experienced rapid commercial development.

Over the past 10 years the City of New Albany in Franklin County has added more than 3 Million Square feet of commercial development including high occupancy hazards such as multi-story hotels, apartments and assisted living centers.

Financial Considerations

The cost of a new ladder truck is estimated to cost between \$1,250,000.00 and \$1,390,000.00. This figure is based upon ordering a new 100' Platform ladder truck or a Tractor Drawn Tiller Ladder truck. These figures are based upon calculations from current manufactures and recent orders from Sutphen Corporation and Pierce Manufacturing using State of Ohio purchasing.

The current PTFD budget has the funds to purchase a new ladder truck. The options are to pay for the purchase of a new ladder truck in cash or to finance the truck at a low interest rate through the manufacturer.

The current 5 year finance options from both manufactures have a current interest rate of 3.5% - 3.9%

With a 5 year payment plan, the new ladder would be paid in full in 2023, with the first payment occurring in 2019.

The PTFD budget has been updated to include a ladder payment in each of the 5 years from 2019 - 2023, and still shows a positive carryover through 2022.

If paying in cash, the PTFD budget can only go through 2021 with a carryover.

This does not include projected revenue increases which are anticipated from increased TIF revenue from the City of New Albany from new developments that are currently in process.

Proposed Timeline

- **Place order for a new ladder truck late spring 2018**
- **Take delivery of the new ladder truck in late 2019**
- **Make first payment in 2019**
- **Make final payment in 2023**

New Ladder Truck Options

The committee reviewed various types of ladder trucks. Due to the high life hazards and numerous 3 and 4 story commercial building, and large estate residences with long setbacks a ladder truck must be 100' tall for our district.

The best option for turning radius and compartment space required to carry our equipment, the committee recommends a mid-mount platform ladder or a tractor drawn aerial ladder.

Truck Specification Needs

A new ladder truck needs to meet current NFPA standards as well as all current safety and mechanical needs of the department.

The new truck needs to carry more ground ladders than our current ladder truck to provide adequate ground ladder coverage for our difficult access to many multi-story building such as the new Market Street apartments and the new 3 story senior living center and 3 new hotels on Forrest Drive.

With the addition of multi round-a-bout intersections and new dense multi-unit residential developments in New Albany, it is becoming more difficult to get the ladder truck through the streets and to the scene of the emergency.

The new ladder truck needs to have a smaller wheel base or ability to make tighter turns to help get the ladder truck to the scene and navigate the smaller streets.

The new ladder truck must be able to carry all of our current equipment and be able to provide ample lighting for night time operations.

The mid-mount platform ladder truck or the tractor drawn ladder trucks are the best options for the needs of community.

Pierce Manufacturing provides the best option for a tractor drawn ladder truck and Sutphen Corporation provides the best option for a mid-mount ladder truck with the aluminum box frame ladder. Both companies provide state bid purchasing and financing options.

Purchase Recommendation

After a 6 month review and information gathering the PTFD Ladder Committee make the following findings.

Both truck options meet our needs and both have pros and cons. However we believe the training and staffing aspect of purchasing a Tiller (TDA) create additional challenges that purchasing a Sutphen platform do not.

Therefore, the committee recommends ordering a new Sutphen SPH 100 in the spring of 2018.

The projected cost of the purchase is \$1,350,000.00

The committee recommends financing through Sutphen Corporation for 5 years.

PROPOSAL

Sutphen has agreed to give PTFD \$60,000 for the trade in of our current ladder truck.

By purchasing the truck in full and financing for 5 years at 3.7%, Sutphen will give Plain Township a prepay discount of \$27,844.00.

With the trade in and prepay discount, the total financed price for the truck will be \$1,262,156.00

This makes our annual payment amount - \$281,844.04

The first payment will occur in 2019 and last payment will be in 2023.

The total amount of interest paid over the 5 year after the trade in amount would be \$47,730. If you apply the pre-pay discount of \$27,844, then the total paid on interest would only be \$19,886.

This proposal allows us to take delivery of a new ladder in late 2019 and allows our budget to have a carryover through 2022.

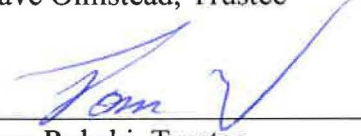

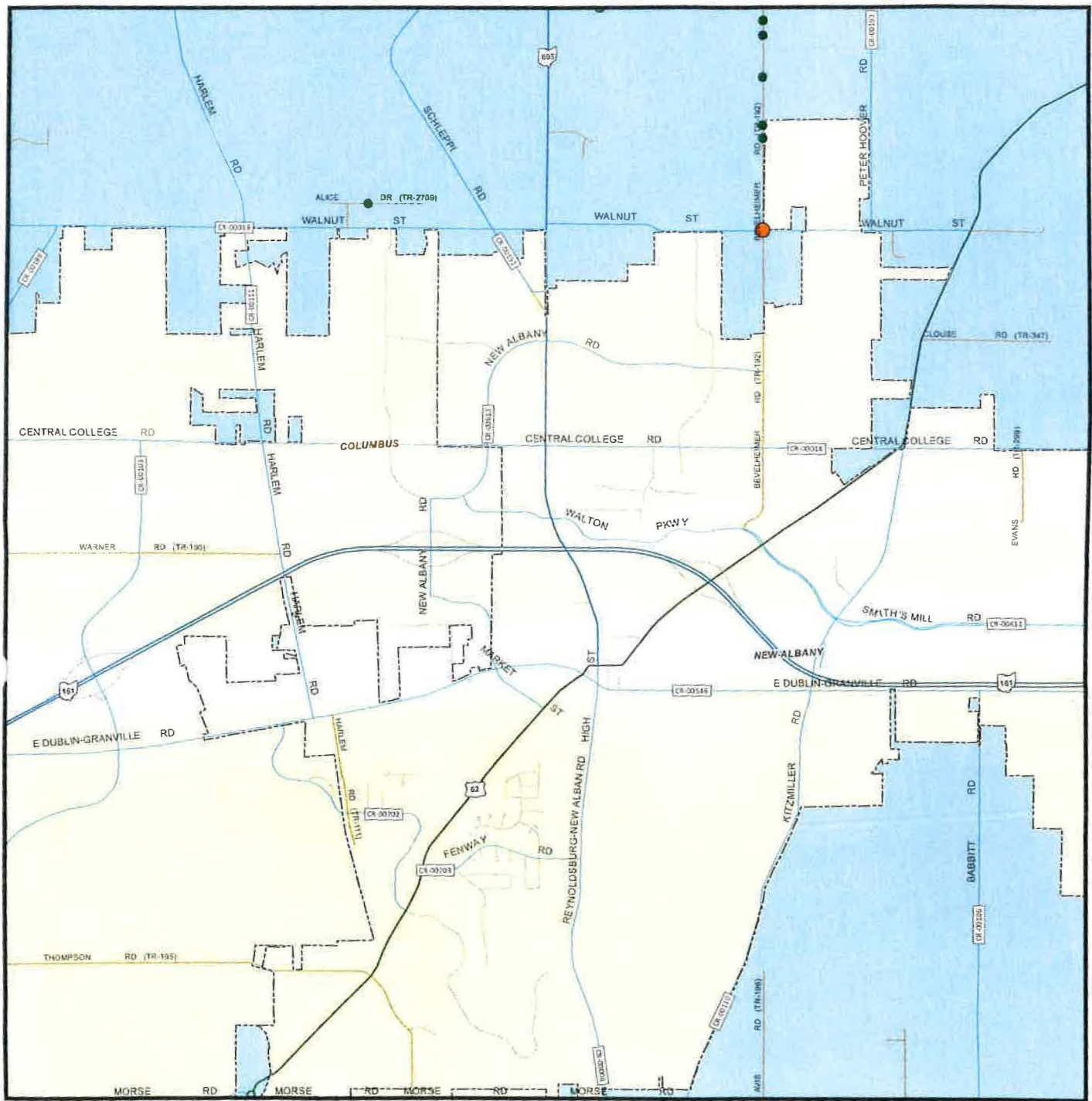
