The Plain Township Board of Trustees met in regular session at the Plain Township Fire Station, 9500 Johnstown Road, New Albany, Ohio.

Mr. Ferguson called the meeting to order with the Pledge of Allegiance to the flag.

Roll Call: Members Present Dave Ferguson, Dave Olmstead and Tom Rybski. Bud Zappitelli, Fiscal Officer, was absent. Other people present were Chief Hoovler, Ben Collins, Bob Pharris, Cindy Powell, Assistant Chief Rupp, Battalion Chief Ecleberry, Lt. Chris Pabst, Lt. Todd Moore, FF Jason Miller, FF Mark Powell, FF Joe Herren, FF Derek Caplinger, FF Joe Pershing and FF Max Newton.

ADDITIONS OR CORRECTIONS TO THE AGENDA

Mr. Ferguson moved an Executive Session after the Pending Warrants.

APPROVAL OF MINUTES

Mr. Rybski made a motion to approve the June 20, 2018 Board of Trustees Meeting minutes as submitted. Mr. Olmstead seconded the motion.

PAYMENT OF THE BILLS

DOUG BURNIP – REVIEW OF ELECTRIC AND NATURAL GAS OPTIONS

Mr. Doug Burnip gave an overview of the current options for electric and natural gas suppliers. Mr. Olmstead asked what his recommendation is. Mr. Burnip said that he would go 24 months on the agreement. There was a brief discussion concerning the electric and natural gas supplier options.

FIRE FIGHTER INTERVIEWS

Mr. Ferguson said there are interviews for two open firefighter positions and six candidates that the trustees will interview in executive session. He asked Chief Hoovler and Mr. Collins to be in the executive session.

FIRE DEPARTMENT

Chief Hoovler said there have been 107 runs since the last Board of Trustees meeting.

Mr. Olmstead made a motion to authorize conditional full time employment to: Nathan Forsthoefel , Derek Choops and Bradley Essick .

Mr. Rybski seconded the motion. Roll Call: All Aye

Chief Hoovler said the hope is to swear them in at the August 1st meeting. They still have to complete their physical agility and medical physicals if necessary. There was a brief discussion concerning schedules and new hire orientation.

FISCAL OFFICE

Mrs. Powell said that we received the 2016 policy year 85% premium rebate from BWC which was \$77,877 total which will go back to the respective funds.

EXECUTIVE SESSION

Mr. Ferguson made a motion to adjourn into executive session at 7:13 p.m. pursuant to Ohio Revised Code 121.22 (G)(1) for appointment, employment, promotion or compensation, demotion or dismissal. Mr. Rybski seconded the motion. Roll Call Vote: All Aye

Chief Hoovler and Mr. Collins also attended the Executive Session.

Mr. Ferguson made a motion to close out of executive session at 9:32 p.m. Mr. Olmstead seconded the motion. Roll Call Vote: All Aye

ADMINISTRATOR

Mr. Collins said that SWACO has asked if the member communities of consortium #1 would consider paying for the cost of recycling from general funds as opposed to residents paying for it. There was a brief discussion concerning the cost and who should pay for it. Mr. Collins said the cost to Plain Township would be around \$13,000. Mr. Olmstead asked when the board needed to make a decision on that. There was a brief discussion concerning timing and when a decision was needed. The board decided that they could discuss it at the next meeting. Mr. Olmstead asked Mr. Collins to get them, for the next meeting, what the dollar amount per household is right now.

Mr. Ferguson made a motion to pass Resolution No. 180705A1. WHEREAS, Ohio Revised Code § 510.707 authorizes a board of township trustees to appropriate from the township general revenue fund moneys not appropriated for any other purpose to an organization that the board determines serves a community purpose and that is exempt from federal taxation under subsection 501(a) and described in subsection 501(c)(3) of the "Internal Revenue Code of 1986," 100 Stat. 2085, 26 U.S.C. 1, as amended; and

WHEREAS, Plain Township has entered into the Second Amended and Restated Joint Operating Agreement for the New Albany Community Arts Center (hereinafter referred to as the "Operating Agreement"), which provide in Section 8.3 that each Owner shall annually deposit in the same proportion as their ownership provided in Section 3.2 the dollar amount necessary to fund the Capital Repair and Replacement Fund of the McCoy Center for the Arts; and

WHEREAS, Section 8.3 of the Operating Agreement provides that the Capital Repairs and Replacements funding from each owner will be deposited into a separate Capital Repair and Replacement Account maintained and managed by the New Albany Community Foundation; and

WHEREAS, in accordance with Section 6.6 of the Operating Agreement, the Board of Education of the New Albany - Plain Local School District has, in cooperation and consultation with the City, the Township, the community Foundation and the Board of Directors, prepared a Five-Year Capital Repairs, Replacements, and Improvement Plan, which includes, by category, budgeting for Capital Repairs/Replacements and for Capital Additions or Improvements; and

WHEREAS, the Owners have reviewed and approved the Five-Year Capital Repairs, Replacements, and Improvement Plan as presented.

NOW, THEREFORE, BE IT RESOLVED BY THE PLAIN TOWNSHIP BOARD OF TRUSTEES, FRANKLIN COUNTY, OHIO:

Section 1. That the New Albany Community Foundation is determined to be an organization that serves a community purpose and is exempt from federal taxation under subsection 501(a) and described in subsection 501(c)(3) of the Internal Revenue Code of 1986, as amended; and

Section 2. That the funds contributed to the New Albany Community Foundation for the Capital Repairs/Replacements of the McCoy Center for the Arts will serve a community purpose; and

Section 3. That the amount of \$24,885.00 be set aside and paid to the New Albany Community Foundation from fund 01-F-08N (NA Comm Fdn-Perf.Arts-Capital Fund Donation), for the purpose of funding Plain Township's proportionate share of the McCoy Center for the Arts Capital Repairs and Replacements according to Section 8.3 of the Second Amended and Restated Joint Operating Agreement for the New Albany Community Arts Center.

Section 4. That this Board of Trustees finds and determines that all formal actions of this Board concerning this legislation were taken in an open meeting of this Board, all in compliance with Ohio law including Section 121.22 of the Ohio Revised Code.

Section 5. That this Resolution is declared to be in full force and effect from and after the earliest period allowed by law.

Mr. Olmstead seconded the motion. Vote: All Aye

Mr. Ferguson made a motion to pass Resolution No. 180705A2. Be it resolved, to set aside and pay Columbus Pool Management, Inc., 8852 Whitney Dr., Lewis Center, OH 43035, \$41,296.00 to cover the August contract payment from fund 14-A-07 (Pool – Contracts).



MCCOY CENTER FOR THE ARTS

The township received the invoice for the annual McCoy Center for the Arts capital maintenance fund in the amount of \$24,885. A resolution to pay this amount is submitted for consideration.

POOL

The next contract payment for pool management is due August 1, and a resolution to set aside and pay the amount is submitted for consideration.

HRA REIMBURSEMENTS

Year to date HRA reimbursements through June 30 total \$51,164. HRA reimbursements through June 19, 2017 totaled \$33,080. OPEC has closed out the township's HRA account from 2017 as no additional 2017 reimbursement requests had been received in the past 90 days.

SWACO

The recycling processing bid came in from Rumpke. Recycling processing has always been a free service to SWACO Consortium #1. We still have one year available to renew at that price. Rumpke bid \$35/ton for recycling processing. SWACO negotiated a lower rate of \$29/ton from Rumpke for 4 years for Consortium #1. Upon further review and reflection by SWACO's legal counsel, the \$35/ton amount will be used for the recycling processing bid.

During the collection pre-bid conference, vendors asked if the communities would pay the recycling processing fee. If not, the residents would likely see their monthly bill fluctuate on a quarterly basis due to the recycling market index. Based on 363 tons of recyclables collected in 2017 in Plain Township, it would cost \$12,705 at \$35/ton. Among the 772 households served, that would be \$16.45 annually or \$1.37 a month.

TOWNSHIP UTILITIES

I met with Doug Burnup to review the township's opportunities to secure favorable rates on natural gas and electric. The current natural gas agreement expires on the 2018 October billing cycle. The current electric agreement expires on the May 2019 billing cycle.

While the rates are in flux due to electric demand during the summer season, there is an opportunity to secure lower rates on both utilities. Attached are current offers compared to the current rates.

Our electric supply agreement is with AEP Ohio and we have an opportunity to continue that agreement with lower rates.

Our natural gas supply agreement is with IGS Energy. I am waiting on rates from Columbia Gas as a local option.

Blend and Extend- if you want lower rate for Pool Usage this Summer this would start on the August Bill. You are currently at \$4.66 per Mcf.

WHEREAS, Ohio Revised Code § 510.707 authorizes a board of township trustees to appropriate from the township general revenue fund moneys not appropriated for any other purpose to an organization that the board determines serves a community purpose and that is exempt from federal taxation under subsection 501(a) and described in subsection 501(c)(3) of the "Internal Revenue Code of 1986," 100 Stat. 2085, 26 U.S.C. 1, as amended; and

WHEREAS, Plain Township has entered into the Second Amended and Restated Joint Operating Agreement for the New Albany Community Arts Center (hereinafter referred to as the "Operating Agreement"), which provide in Section 8.3 that each Owner shall annually deposit in the same proportion as their ownership provided in Section 3.2 the dollar amount necessary to fund the Capital Repair and Replacement Fund of the McCoy Center for the Arts; and

WHEREAS, Section 8.3 of the Operating Agreement provides that the Capital Repairs and Replacements funding from each owner will be deposited into a separate Capital Repair and Replacement Account maintained and managed by the New Albany Community Foundation; and

WHEREAS, in accordance with Section 6.6 of the Operating Agreement, the Board of Education of the New Albany - Plain Local School District has, in cooperation and consultation with the City, the Township, the community Foundation and the Board of Directors, prepared a Five-Year Capital Repairs, Replacements, and Improvement Plan, which includes, by category, budgeting for Capital Repairs/Replacements and for Capital Additions or Improvements; and

WHEREAS, the Owners have reviewed and approved the Five-Year Capital Repairs, Replacements, and Improvement Plan as presented.

**NOW, THEREFORE, BE IT RESOLVED BY THE PLAIN TOWNSHIP BOARD OF
TRUSTEES, FRANKLIN COUNTY, OHIO:**

Section 1. That the New Albany Community Foundation is determined to be an organization that serves a community purpose and is exempt from federal taxation under subsection 501(a) and described in subsection 501(c)(3) of the Internal Revenue Code of 1986, as amended; and

Section 2. That the funds contributed to the New Albany Community Foundation for the Capital Repairs/Replacements of the McCoy Center for the Arts will serve a community purpose; and

Section 3. That the amount of \$24,885.00 be set aside and paid to the New Albany Community Foundation from fund 01-F-08N (NA Comm Fdn-Perf.Arts-Capital Fund Donation), for the purpose of funding Plain Township's proportionate share of the McCoy Center for the Arts Capital Repairs and Replacements according to Section 8.3 of the Second Amended and Restated Joint Operating Agreement for the New Albany Community Arts Center.

Section 4. That this Board of Trustees finds and determines that all formal actions of this Board concerning this legislation were taken in an open meeting of this Board, all in compliance with Ohio law including Section 121.22 of the Ohio Revised Code.

Section 5. That this Resolution is declared to be in full force and effect from and after the earliest period allowed by law.







I contacted Aaron Underhill and the New Albany Company about the storm water issue reported by Bart Anderson. A NACO representative has contacted the farmer. To rule out any obstruction in the storm sewer, the township has requested to have the storm sewers inspected but the sewer camera for both Franklin County and New Albany are out of commission.

Bobby observed the storm water issue during a recent rain event. The issue is storm water washing away a small amount of mulch around a resident's mail box. We have a tentative plan to place dump rock at the edge of the ROW to break up the flow of storm water coming off of the field. We are also assessing how to place a structure at the end of each storm tile to capture more of the storm water flowing off of the field.
