# Variance Application 1-10-2023-01 – 13320 Bevelhymer Road - requesting a variance under Section 406.02 to allow a second accessory structure (a pool) that would be 324 square feet more than the permitted 144 square footage.

Mrs. Val Jorgensen presented the application. The requested pool is considered to be an accessory structure and per the township zoning resolution only one accessory structure over 144 square feet is allowed. Since the subject property has a detached garage, the pool needs a variance in order to be allowed. Mr. Jim Moore with Moore Construction indicated that water would be brought in via Delco Water with a tanker. It is approximately 24,000-25,000 gallons.
